When faculty plan to support PhD students, they should budget for: (1) **Stipend** & (2) **Sponsor Tuition**.

[Stipends](#) are charged on the monthly payroll schedule. Sponsor Tuition is charged monthly based on the stipend funding source.

The chart below represents the applicability of Sponsor Tuition by funding source. If tuition is not an allowable cost on the stipend funding source (i.e., Speedtype), faculty must provide a substitute Speedtype for the Sponsor Tuition charge. When a student is funded by an individual fellowship or institutional training grant that provides tuition in excess of the Sponsor Tuition amount, the faculty sponsor will not be charged Sponsor Tuition.
